

**CONTRACT FOR THE PROTECTION AND MAINTENANCE OF NIPA STAND FOR BIOETHANOL
PRODUCTION**

This **AGREEMENT**, made and executed by and between –

The **MARIANO MARCOS STATE UNIVERSITY**, with office at Batac City, Ilocos Norte, an education institution created under and by virtue of PD 1279, represented in this ACT by **DR. SHIRLEY C. AGRUPIS**, duly authorized in her capacity as President, hereinafter referred to as "**MMSU**"

And

BINMALEY SUMISIGAY FEDERATION INC., a corporation with office at Municipal Building Plaza Rizal Poblacion Binmaley Pangasinan, represented by **MR. CONRADO A. VICTORIO**, President, hereinafter referred to as the "**LABOR PROVIDER**".

WITNESSTH: That-

WHEREAS, MMSU, is in need of skilled manpower to provide labor for the protection and maintenance of nipa stand for bioethanol production (the "**UNDERTAKING**");

WHEREAS, MMSU canvassed from three (3) labor groups in the area and the service provider has the lowest calculated and responsive bid;

WHEREAS, the **CONTRACTOR**, represented himself as having a valid license, knowledge, skill and expertise, as well as the legal, technical and financial resources, to do the **UNDERTAKING**.

WHEREAS, the parties are now ready to commence the **PROJECT** and must now execute a written document to reflect their respective roles in the **UNDERTAKING** as best as they could.

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereunto agreed to this Contract under the following terms and conditions:

1. The **LABOR PROVIDER** shall execute the **UNDERTAKING** as described in the first **WHEREAS** clause hereof, to the best of his ability, in accordance with relevant laws, rules and regulations and to the full satisfaction of **MMSU**.
2. For and in consideration of the **UNDERTAKING** to the satisfaction of **MMSU**, and upon submission of proof of completed services relative to the **UNDERTAKING**, **MMSU** shall pay the **LABOR PROVIDER** a labor fee in the amount of **TWO THOUSAND PESOS (P2,000.00)** per hectare but not to exceed **FOUR HUNDRED TWENTY THOUSAND PESOS (P420,000.00)**.

3. In case of violations of any provision of this Contract, MMSU shall automatically rescind and/or terminate the same with the right to award or negotiate the said services to another service provider.

4. This contract shall take effect on December 01, 2021 until June 30, 2022.


