

CONTRACT FOR TARPAULIN PRINTING

This **AGREEMENT**, made and executed by and between –

The **MARIANO MARCOS STATE UNIVERSITY**, with office at Batac City, Ilocos Norte, an education institution created under and by virtue of PD 1279, represented in this ACT by **DR. SHIRLEY C. AGRUPIS**, duly authorized in her capacity as President, hereinafter referred to as "**MMSU**"

And

GCM COLLECTIONS, a sole proprietorship with office at Brgy. Ablan, City of Batac, Ilocos Norte, represented by **MS. MARTHA LOUISE AURORA M. BORLEO**, Proprietor, hereinafter referred to as the "**SERVICE PROVIDER**".

WITNESSTH: That-

WHEREAS, MMSU, is in need of the services of a Tarpaulin Printer to provide for the printing of tarpaulins following the specifications required by the university.

WHEREAS, MMSU canvassed from three (3) service providers, the **Printing of Tarpaulin, Assorted Sizes (1 lot)** for the 44th Foundation Anniversary Celebration and for Other University Activities, General Use for the month of January-June 2022 (the "**UNDERTAKING**"),

WHEREAS, the **SERVICE PROVIDER**, represented himself as having a valid license, knowledge, skill and expertise, as well as the legal, technical and financial resources, to do the **UNDERTAKING**.

WHEREAS, the parties are now ready to commence the **PROJECT** and must now execute a written document to reflect their respective roles in the **UNDERTAKING** as best as they could.

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereunto agreed to this Contract under the following terms and conditions:

1. The **SERVICE PROVIDER** shall execute the **UNDERTAKING** as described in the first **WHEREAS** clause hereof, to the best of his ability, in accordance with relevant laws, rules and regulations and to the full satisfaction of **MMSU**.
2. For and in consideration of the **UNDERTAKING** to the satisfaction of **MMSU**, and upon submission of proof of completed services relative to the **UNDERTAKING**, **MMSU** shall pay the **SERVICE PROVIDER** a service fee in the amount of **THIRTEEN PESOS (P13.00) PER SQ. FT. but not to exceed the ABC of P203,485.00**.

- 3. In case of violations of any provision of this Contract, MMSU shall automatically rescind and/or terminate the same with the right to award or negotiate the said services to another service provider.
