Resolution to Award the Project, Establishment and/or Support to the College of Medicine (CO Component: Finishing of the College of Medicine Academic, Research and Support Facilities Building) to ECDI Engineering & Construction (ECDI)

WHEREAS, the Mariano Marcos State University (the "UNIVERSITY") advertised the Invitation to Bid the Construction of University Health and Wellness Center Building, MMSU, City of Batac (the "PROJECT") and in the Public Bidding, ECDI Engineering & Construction (ECDI) of 3rd Flr. RSRK Building, Brgy. Biday, City of San Fernando, La Union offered the Single Calculated Bid and after post-qualification, ECDI was declared responsive to all the requirements and conditions of the PROJECT. The PROJECT was therefore awarded to ECDI and is scheduled for completion on July 16, 2022;
